BJ SERVICES COMPANY (BJS) - Merger Completed with BAKER HUGHES, INC. (BHI)

On Friday, March 19, 2010, the shareholders of BJ Services Company (BJS) will voted and approved the proposed merger with Baker Hughes, Inc. (BHI). If the merger is approved and consummated, each BJS share will be converted into the right to receive .40035 BHI Common Shares and \$2.69 cash. Cash will be paid in lieu of fractional BHI shares.
The merger became effective on Wednesday, April 28, 2010.
