**1 for 10 Reverse Stock Split**  
**Ex-Distribution Date: 5/27/2009**

Coeur d'Alene Mines Corporation IDA (CDE) has declared a 1 for 10 stock split payable to shareholders of record Friday, May 29, 2009. As a result of the reverse stock split, each CDE Common Share will be converted into the right to receive .10 (New) Coeur d'Alene Mines Corporation Common Shares. **Ex-distribution date for the stock split will be Wednesday, May 27, 2009.**
