Cablevision Systems Corp (CVC) has declared a distribution of Madison Square Garden Class A Common Stock (MSG) to CVC shareholders of record Monday, January 25, 2010. The distribution will be 0.25 Common shares of MSG per Class A Common Share of CVC. **Ex-distribution is Wednesday, February 10, 2010.**

Madison Square Garden Class A Common Shares are currently trading when issued on the NASDAQ NMS under the symbol MSGNV.
