DESCRIPTION:

Furniture Brands International, Inc. (FBN) has announced a 1-for-7 reverse stock split. As a result of the reverse stock split, each FBN Common Share will be converted into the right to receive .142857 (New) Furniture Brands International, Inc. Common Shares. The reverse stock split will become effective before the market open on May 29, 2013.

Contract Adjustments:

Pursuant to the By-Laws of the Options Clearing Corporation ("OCC"), the below options will be adjusted as follows.

On Monday, May 28, 2013, immediately after the BOX close, all resting orders for FBN in the order book will be canceled by the BOX Market Operations Center. If a BOX Participant wishes to enter orders for the new FBN1 series, the BOX Participant will need to reenter the orders before the open on Tuesday, May 29, 2013.
