### COGO GROUP, INC. - NAME/SYMBOL/CUSIP CHANGE

#### DESCRIPTION:

The Options Clearing Corporation (OCC) has been advised that Cogo Group, Inc. (COGO) will change its name, trading symbol, and CUSIP to Viewtran Group, Inc. (VIEW), CUSIP G9363W104. As a result, option symbol COGO will also change to VIEW effective at the opening of business on November 26, 2013.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol VIEW commencing November 26, 2013.
