DESCRIPTION:

On April 15, 2014, Shareholders of ATMI, Inc. (ATMI) voted concerning the proposed merger with Atomic Merger Corporation, a wholly-owned subsidiary of Entegris, Inc. The merger was approved and subsequently consummated before the open on April 30, 2014. As a result, each existing ATMI Common Share will be converted into the right to receive \$34.00 net cash per share.
