TOWER GROUP INTERNATIONAL, LTD. - CASH SETTLEMENT/ACCELERATION OF EXPIRATIONS

DESCRIPTION:

On August 6, 2014, Shareholders of Tower Group International, Ltd. (TWGP) voted concerning the proposed merger with London Acquisition Company Limited, a wholly-owned subsidiary of ACP Re, Ltd. The merger was approved and subsequently consummated before the open on September 15, 2014. As a result, each existing TWGP Common Share will be converted into the right to receive \$2.50 net cash per share.

ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series.
