### DESCRIPTION:

Hansen Medical, Inc. (HNSN) has announced a 1-for-10 reverse stock split. As a result of the reverse stock split, each HNSN Common Share will be converted into the right to receive 0.10 (New) Hansen Medical, Inc. Common Shares. The reverse stock split will become effective at the market open on September 23, 2015.

### Contract Adjustments:

Pursuant to the By-Laws of the Options Clearing Corporation ("OCC"), the below options will be adjusted as follows.

If a BOX Participant wishes to enter orders for the new HNSN1 series, the BOX Participant will need to reenter the orders before the open on Wednesday, September 23rd, 2015.
