SUBJECT: Market Maker Pre-Opening Spread Requirements

DATE: October 21, 2013

Beginning **November 4, 2013**, Market Makers on the BOX Options Exchange that choose to quote during the pre-opening phase will no longer be required to quote in the narrower spread differential. Instead, Market Makers who choose to quote in the pre-opening phase will be required to quote within the standard bid ask-differential of \$5. All other Market Maker quoting obligations remain the same and can be accessed at Rule 8040 (Obligations of Market Makers).
