SUBJECT: **Removal of Bid Ask Relief at the Open**
DATE: **October 31, 2013**

Beginning **November 4, 2013** Market Makers on BOX Option Exchange that choose to quote during the pre-opening phase will no longer be required to quote in the narrower spread differential. Therefore, the allowance for double the required bid/ask width at the open granted in [RC-2013-12](#) will no longer apply in the names listed below.
