**Effective April 1, 2024**, BOX Options Market LLC ("BOX") is making the following changes to the BOX Fee Schedule.<sup>1</sup>

## **Complex Order Transaction Fees**

BOX is separating SPY, QQQ, and IWM from Penny Interval Classes in the Complex Order transaction fee structure. The SPY, QQQ, and IWM transaction fees for Complex Orders will remain the same as the fees currently assessed for Penny Interval Classes.

## **Orders on BOX Book Executed Against Complex Orders**

BOX is decreasing the fee assessed to each leg of a Public Customer Complex Order in SPY, QQQ, and IWM when each leg of the Complex Order executes against an order on the BOX Book.

Currently, each order on the BOX Book executed against a Complex Order and each leg of a Complex Order executed against the BOX Book is treated as a standard order for purposes of the Fee Schedule and subject to Section IV.A (Electronic Transaction Fees for Non-Auction Transactions). Following this change, each leg of a Public Customer Complex Order in SPY, QQQ, and IWM executed against an order on the BOX Book will be assessed \$0.00.
