Banco BBVA Argentina S.A. (BBAR) has announced a payment of a dividend in kind of Argentine Bonds to holders of BBAR Ordinary Shares. Since the dividend in-kind cannot be distributed to ADR holders, BNY Mellon, as depositary, announced it has sold the bonds received in this pay in kind dividend and will distribute \$0.058834 per BBAR American Depositary Share. The record date is July 24, 2023; the payable date is July 31, 2023. The ex-distribution date for this distribution will be July 21, 2023.
