Banco Macro S.A. (BMA) has announced a payment of a dividend in-kind of Argentine Bonds to holders of BMA Class B Common Shares. Since the dividend in-kind cannot be distributed to ADR holders, BNY Mellon, as depositary, announced it has sold the bonds received in this dividend and will distribute \$0.451985 per BMA American Depositary Share. The record date is August 7, 2023; the payable date is August 14, 2023. The ex-distribution date for this distribution will be August 4, 2023.
