#### **DESCRIPTION:**

LiveOne, Inc. (LVO) has announced a distribution of (New) Courtside Group Inc. (PODC) Common Shares. The distribution ratio is 0.04761905 of a PODC share for each LVO share held. The record date is August 28, 2023 (formerly May 11, 2023); the payable date is September 1, 2023. The NASDAQ has set September 5, 2023, as the ex-distribution date for this distribution. Treatment of fractional shares is not known at this time.

Courtside Group Inc. Common Shares are expected to begin trading regular way on the Nasdaq Global Market under the symbol "PODC" on September 8, 2023.

### **Delayed Settlement**

The LVO component of the LVO1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the PODC component and cash portion, if any, of the LVO1 deliverable until the regular way trading commences and cash in lieu of fractional PODC shares is determined.
