DESCRIPTION:

Inseego Corporation (INSG) has announced a 1-for-10 reverse stock split. As a result of the reverse stock split, each INSG Common Share will be converted into the right to receive 0.1 (New) Inseego Corporation Common Shares. The reverse stock split will become effective before the market open on January 24, 2024.

Contract Adjustments:

Pursuant to the By-Laws of the Options Clearing Corporation ("OCC"), the below options will be adjusted as follows.
