YieldMax TSLA Option Income Strategy ETF (TSLY) has announced a 1-for-2 reverse stock split. As a result of the reverse stock split, each TSLY Share will be converted into the right to receive 0.5 (New) YieldMax TSLA Option Income Strategy ETF Shares. The reverse stock split will become effective before the market open on February 26, 2024.
