### DESCRIPTION:

Adverum Biotechnologies, Inc. (ADVM) has announced a 1-for-10 reverse stock split. As a result of the reverse stock split, each ADVM Common Share will be converted into the right to receive 0.1 (New) Adverum Biotechnologies, Inc. Common Shares. The reverse stock split will become effective before the market open on March 21, 2024.
