Tricon Residential Inc. - Cash Settlement/Acceleration of Expirations

DESCRIPTION:

On March 28, 2024, Shareholders of Tricon Residential Inc. (TCN) voted on a proposed Scheme of Arrangement with Creedence Acquisition ULC, an entity formed by Blackstone Real Estate Partners X L.P. and Blackstone Real Estate Income Trust. The Scheme of Arrangement with Creedence Acquisition ULC was approved and subsequently consummated on May 1, 2024. As a result, each existing TCN Common Share will be converted into the right to receive \$11.25 net cash per share.

Settlement in TCN options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Tricon Residential Inc. options whose expiration dates are after 05-17-2024 will have their expiration dates advanced to 05-17-2024. Expiration dates occurring before 05-17-2024 (e.g., Flex options) will remain unchanged.

All Tricon Residential Inc. options will utilize a \$.01 exercise threshold.
