Delayed Settlement

OCC will delay settlement of the DNMR and Dividend Warrant components of DNMR1 options until the contingency is met and the trading status of the warrants is determined.

NOTE: The Dividend Warrants are expected to expire at 5:00 p.m. on the first anniversary of the warrants distribution date. The warrant component, if any, of adjusted option DNMR1 will remain part of the DNMR1 deliverable until the warrants have expired. Once the expiration of the warrants has been confirmed, the warrants will be removed from the DNMR1 deliverable.
