DESCRIPTION:

Lufax Holding Ltd (LU) has announced a Special Dividend of approximately \$2.42, less fees, if any, per LU American Depositary Share. LU ADS holders who do not make a valid election will receive the Special Dividend in the form of cash. The record date is June 4, 2024; payable date is August 6, 2024. The election deadline is unknown at this time.

Exercise Consideration - On June 4, 2024, LU options will be become adjusted symbol LU2.
