## Snap One Holdings Corporation - Cash Settlement

### DESCRIPTION:

On April 14, 2024, Principal Stockholders, which owned approximately 72% of the then outstanding shares of Snap One Holdings Corporation (SNPO), delivered written consent approving the merger agreement between SNPO and Pop Acquisition Inc., a wholly owned subsidiary of Resideo Technologies, Inc. If and when the merger is consummated, each existing SNPO Common Share will be converted into the right to receive \$10.75 net cash per share.

Settlement in SNPO options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series (See OCC Information Memo 23988).
