WalkMe Ltd. - Cash Settlement

DESCRIPTION:

On August 7, 2024, Shareholders of WalkMe Ltd. (WKME) voted concerning the proposed merger with Hummingbird Acquisition Corp Ltd., a wholly owned subsidiary of SAP SE. The merger was approved and subsequently consummated before the open on September 12, 2024. As a result, each existing WKME Ordinary Share will be converted into the right to receive \$14.00 cash per share, less withholdings, if any.

NOTE: WalkMe Ltd. submitted an application to the Israeli Tax Authority which includes a request that non-Israeli shareholders be exempt from Israeli withholding, if such stockholders will provide the paying agent in Israel with certain declarations and supporting documents regarding their residency and the date on which their shares were purchased, and satisfy other conditions as stated in the WKME Proxy Statement dated July 1, 2024 ("Proxy"). Investors are referred to the Proxy for a complete discussion of relevant tax considerations. As indicated below, the deliverable of adjusted WKME options will be based on the merger consideration net of applicable withholding taxes, if any.

OCC will delay settlement of the WKME deliverable until the final net cashmerger consideration is confirmed. Once the final amount is determined, settlement in WKME options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series (See OCC Information Memo 23988).
