## ProShares UltraShort Russell2000 - Reverse Split

### DESCRIPTION:

ProShares UltraShort Russell2000 (TWM) has announced a 1-for-5 reverse stock split. As a result of the reverse stock split, each TWM Share will be converted into the right to receive 0.2 (New) ProShares UltraShort Russell2000 Shares. The reverse stock split will become effective before the market open on November 7, 2024.
