DESCRIPTION:

Tradr 2X Short TSLA Daily ETF (TSLQ) has announced a 1-for-6 reverse stock split. As a result of the reverse stock split, each TSLQ Share will be converted into the right to receive approximately 0.166667 (New) Tradr 2X Short TSLA Daily ETF Shares. The reverse stock split will become effective before the market open on November 27, 2024. Cash will be paid in lieu of fractional shares.

Delayed Settlement

The TSLQ component of the TSLQ1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the TSLQ1 deliverable until the cash in lieu of fractional TSLQ Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

Pursuant to the By-Laws of the Options Clearing Corporation ("OCC"), the below options will be adjusted as follows.
