Amarin Corporation plc (AMRN) has announced a 1-for-20 reverse stock split. As a result of the reverse stock split, each AMRN American Depositary Share will be converted into the right to receive 0.05 (New) Amarin Corporation plc American Depositary Shares. The reverse stock split will become effective before the market open on April 11, 2025.
