QVC Group, Inc. Series A (QVCGA) has announced a 1-for-50 reverse stock split. As a result of the reverse stock split, each QVCGA Common Share will be converted into the right to receive 0.02 (New) QVC Group, Inc. Series A Common Shares. The reverse stock split will become effective before the market open on May 23, 2025.
