DESCRIPTION:

ProShares UltraShort MSCI Brazil Capped (BZQ) has announced a 1-for-2 reverse stock split. As a result of the reverse stock split, each BZQ share will be converted into the right to receive 0.5 (New) ProShares UltraShort MSCI Brazil Capped ETF shares. The reverse stock split will become effective before the market open on November 20, 2025.
