DESCRIPTION:

ProShares UltraShort Semiconductors (SSG) has announced a 1-for-4 reverse stock split. As a result of the reverse stock split, each SSG share will be converted into the right to receive 0.25 (New) ProShares UltraShort Semiconductors ETF shares. The reverse stock split will become effective before the market open on November 20, 2025.
