DESCRIPTION:

Sutro Biopharma, Inc. (STRO) has announced a 1-for-10 reverse stock split. As a result of the reverse stock split, each STRO Common Share will be converted into the right to receive 0.1 (New) Sutro Biopharma, Inc. Common Shares. The reverse stock split will become effective before the market open on December 3, 2025.
