**Adicet Bio, Inc. - Reverse Split**

DESCRIPTION:

Adicet Bio, Inc. (ACET) has announced a 1-for-16 reverse stock split. As a result of the reverse stock split, each ACET Common Share will be converted into the right to receive 0.0625 (New) Adicet Bio, Inc. Common Shares. The reverse stock split will become effective before the market open on December 30, 2025. Cash will be paid in lieu of fractional shares.

Note: Once determined the cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.
