**DESCRIPTION:**

Trust for Professional Managers CrossingBridge Pre-Merger SPAC ETF (SPC) will change its name and trading symbol to Trust for Professional Managers CrossingBridge Ultra-Short Duration ETF (CUSD) effective January 28, 2026. As a result, option symbol SPC will also change to CUSD effective at the opening of business on January 28, 2026.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol CUSD commencing January 28, 2026.
