**Atossa Therapeutics, Inc. - Reverse Split**

DESCRIPTION:

Atossa Therapeutics, Inc. (ATOS) has announced a 1-for-15 reverse stock split. As a result of the reverse stock split, each ATOS Common Share will be converted into the right to receive approximately 0.066667 (New) Atossa Therapeutics, Inc. Common Shares. The reverse stock split will become effective before the market open on February 2, 2026. Cash will be paid in lieu of fractional shares.

Delayed Settlement

The ATOS component of the ATOS1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the ATOS1 deliverable until the cash in lieu of fractional ATOS Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
