### DESCRIPTION:

Global Medical REIT Inc. (GMRE) will change its name and trading symbol to Chiron Real Estate Inc. (XRN) effective February 23, 2026. As a result, option symbols GMRE/GMRE1 will also change to XRN/XRN1 effective at the opening of business on February 23, 2026.
