DESCRIPTION:

Ryerson Holding Corporation (RYI) will change its trading symbol to RYZ effective February 24, 2026. As a result, option symbols RYI/RZY1 will also change to RYZ/RZY1 effective at the opening of business on February 24, 2026.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbols RYZ/RZY1 commencing February 24, 2026.
