### DESCRIPTION:

Direxion Daily TSLA Bear 1X ETF (TSLS) has announced a 1-for-10 reverse stock split. As a result of the reverse stock split, each TSLS Share will be converted into the right to receive 0.1 (New) Direxion Daily TSLA Bear 1X ETF Shares. The reverse stock split will become effective before the market open on March 10, 2026.

### Contract Adjustments:
