## SCYNEXIS, Inc. - Reverse Split

### DESCRIPTION:

SCYNEXIS, Inc. (SCYX) has announced a 1-for-8 reverse stock split. As a result of the reverse stock split, each SCYX Common Share will be converted into the right to receive 0.125 (New) SCYNEXIS, Inc. Common Shares. The reverse stock split will become effective before the market open on June 1, 2026. Cash will be paid in lieu of fractional shares.

#### Delayed Settlement

The SCYX component of the SCYX1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the SCYX1 deliverable until the cash in lieu of fractional SCYX Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

### Contract Adjustments:

Pursuant to the Rules of the Options Clearing Corporation ("OCC"), the below options will be adjusted as follows.
