DESCRIPTION:

Intercure Ltd. (INCR) has announced a 1-for-5 reverse stock split. As a result of the reverse stock split, each INCR Ordinary Share will be converted into the right to receive 0.2 (New) Intercure Ltd. Ordinary Shares. The reverse stock split will become effective before the market open on August 24, 2026.
