BOX Options Exchange is pleased to announce the implementation of its **Complex Order Book** (*subject to SEC approval*) scheduled at the end of 2012. All Participants are therefore required to update to the latest versions of the various BOX services they are using:

- **SAIL** (Regular Order Entry/Auctions and Market Making)
- **FIX** (Regular Order Entry/Auctions)
- **HSVF** (Market Data Feed)
- **ATR** (Post-Trading Drop Copy)

The launch of these new versions is scheduled for October 1, 2012. On January 14, 2013, all prior protocols/versions will be decommissioned.

The following new protocols/versions will support Complex Orders:

- SAIL Protocol A6
- FIX latest specifications
- HSVF Protocol C4
- ATR latest specifications (available on port 20200)

# A complete re-certification is required for all Participants using the SAIL and FIX services.

	April	Information Circular to describe the Trading implementation details of the Complex Order Book and related functionalities.

2	May-June	Complex Order Participant Implementation Road Show (more info to come)
201	June 15	Test environment ready for Participants to start testing the new protocols/versions.
	August 1	Re-certification process begins (SAIL and FIX). Participants are invited to call the BOX Market Operations Center to schedule their re-certification session.
	October 1	Technical launch of Complex Order (Trading on the Complex Order Book is not yet activated). Support of new protocols/versions.
