SUBJECT: Participant Market Simulation Prior To System Upgrade - NEW DATE

DATE: April 27, 2012

BOX Options Exchange is pleased to announce an important upgrade of the BOX SOLA[®] Trading Engine that will improve response time on all regular orders.

Note: BOX Participants are not required to perform any system change as this upgrade is planned to be entirely transparent.

This upgrade is scheduled to be implemented on Monday, June 4, 2012. Therefore, BOX is inviting all Participants to join in a Market Simulation that will be held on Saturday, <u>June 2nd</u>.

Simulation Details

- The Market Simulation will take place in a simulation test environment, <u>not</u> in the BOX production environment.
- Participants do not have to make any network or configuration changes. The same IP addresses, port numbers and Logins/IDs as the ones from the production environment will be used.
- The BOX regular production environment will start on Sunday, June 3rd.
- Participants must send Day orders only as BOX will not cancel any outstanding orders at the end of the Simulation.
- All <u>trades</u> done during the simulation will be cancelled at the end by the BOX Market Operation Center. No trades will be sent to OCC.
- For the selected option instrument, BOX will simulate NBBO coming from other option exchanges.
- Connections for Participants not having confirmed their participation will be de-activated for the duration of the simulation.
- Participants joining in the simulation will be required to send at least one order or quote on each of the selected options instruments and to trade against them.
