Several old Protocol versions associated with SOLA® Trading Services will be eliminated by the end of the year.

### Timeline

The old Protocol versions will be available until Friday **November 15, 2013**. Starting Monday November 18, Participants will be required to connect to BOX using the latest Protocol versions described below.

### Impacts Summary

Only the following Protocol versions will be supported:

Participants using SAIL and FIX services and not already using the latest Protocol versions will be required to re-certify their applications.

Participants specify the SAIL protocol version when the SAIL connection is established. Protocols "A0", "A1", "A2" and "A5" will be decommissioned.
