## SUBJECT: Market Simulation for Hardware Upgrade

## DATE: October 2, 2013

BOX Options Exchange will be upgrading the hardware and network infrastructure on the BOX SOLA<sup>®</sup> Trading platform on Monday, November 18, 2013.

Prior to the upgrade, BOX invites Participants to join in a Market Simulation ("Simulation") on **Saturday, November 16.** 

While Participants are not required to make any system changes as part of this upgrade, BOX encourages Participants to join the Simulation to validate the changes that will be made to the network infrastructure. This will help mitigate any potential risks related to connectivity.

## Simulation Details:

- The Simulation will take place in the BOX production environment using the same IP addresses, port numbers and Logins/IDs as those currently used to trade on BOX.
- Participants joining the Simulation will be able to send orders or quotes and connect to their normal BOX services.
- Participants must **only** send Day Orders, as BOX will not cancel outstanding orders at the end of the Simulation.
- All **trades** done during the Simulation will be cancelled at the end by the MOC. No trades will be sent to OCC.
- All listed instruments will be available, but will remain in pre-opening for the duration of the Simulation. Only the instruments listed in the table below will be available to trade.
- BOX will provide an NBBO for only those instruments trading during the Simulation. These instruments are:

10:00 a.m. ET	Physical and logical connection to BOX services (FIX, SAIL, HSVF, ATR, FTP Server and TMS)	
10:00 a.m. ET to 10:30 a.m. ET	Pre-opening period. Participants can send orders (Day only) and quotes.	
10:30 a.m. ET to 12:00 p.m. ET	Trading period starts. Participants can send orders (Day only) and quotes.	
12:00 p.m. ET to 1:00 p.m. ET	Fail-over test. Participants will be disconnected and will need to re-establish their connection(s).	
1:00 p.m. ET	Market simulation ends. BOX MOC cancels all trades done during the Simulation.
