SUBJECT: Update to Trade Detail Files - NEW DATE

DATE: December 11, 2020

BOX Options ("BOX") previously distributed <u>IC-2020-32</u> stating that effective Monday, January 4, 2021, BOX would release a new version of the daily and monthly trade detail files.

The implementation of the new trade detail file format will now begin on **February 1, 2021**. BOX will continue to distribute the trade detail files in the current format until then.

Beginning on **February 1, 2021**, the monthly and daily trade detail files will include eleven new fields added to the end of the files as detailed below. Please note that the January 2021 Monthly Trade Detail file which is published in early February will be in the new file format.

The new fields are as follows:

As a reminder, BOX Participants are able to obtain daily and monthly files detailing their trading activity. These files include billing information on a trade-by-trade basis.

- Files will be available on a daily basis by 2:00 AM EST
- Files can be downloaded using Internet SFTP or a Secure FTP site with IP Address: **198.235.27.150**
- Each file is in Comma Separated Value (CSV) format
- Headers are included in the file
- File Time Periods include:
  - Daily (T+1): All trades by the firm for the previous trading date
  - Cumulative (Monthly): Aggregated trades by firm for the month
- File Naming Convention:
  - Daily (T+1): FIRMID\_YYYYMMDD.csv
     Note: If there were no trades executed by the firm for the current day, then the daily file will be empty
  - Cumulative (Monthly): FIRMID\_YYYYMM.csv.
- Files will be available on the FTP site for the current and previous month
