SUBJECT: Penny Program Annual Rebalancing

DATE: December 31st, 2020

The permanent Penny Interval Program for options (the "Penny Program"), was adopted on July 1, 2020 by BOX Exchange LLC ("BOX") and includes provisions for annual rebalancing of the Penny Program. Effective **January 4th, 2021**, BOX will update the list of issues in the Penny Program pursuant to the Annual Review provided for in the Penny Program, as described by the criteria below:

 Additions to the Penny Program: Based on the Annual Review, any option class not in the Penny Program that is among the 300 most actively traded multiply listed option classes overlying securities priced below \$200, or an index at an index level below \$200, will be added to the Penny Program on the first trading day of January

In accordance with such criteria, the following issues will be added to the Penny Program effective **January 4th**, **2021**:
