Beginning **October 18, 2021**, the tags on the Leg Instrument Execution Report in FIX '8' will mirror the tags of the parent FIX '8' Complex Order Execution Report.

The following tags currently exist in FIX '8' (Execution Report) in both BOX (B4 and B5) protocols. Please note that if used on the Complex Order entry, Tag 9383 (AuctionType) in FIX '8' will now be sent back to the Participant.
