**Effective January 2, 2024**, BOX Options Market LLC ("BOX") is making the following changes to the BOX Fee Schedule:<sup>1</sup>

In Section IV.A, BOX is decreasing Professional Customer or Broker Dealer maker fees for non-auction transactions when trading contra to Public Customers in Penny Interval Classes and SPY. Additionally, BOX is amending Section IV.A of the BOX Fee Schedule to establish separate fees for QQQ and IWM non-auction transactions. The fees will be as follows:
